Attached hereto please find bond reduction estimate for the completed Peaceful Court Extension and related storm water facilities, as well as the recently completed improvements to the Cronk Road/Peaceful Court Intersection. The re-striping and additional sign requested at your site inspection with Darrell Benedict 3/22/12 have been installed as directed.

Included herewith is our as-built plan done in conjunction with Darren Stridiron, L.S. of Heritage Land Surveying for your review and comment. The plan includes both engineers and surveyor certifications for the improvements depicted on said plan. It is both noted in our bond reduction estimate and the as-built plan that minor modifications are necessary to the storm water facilities before they can be considered complete and our estimate reflects this.
