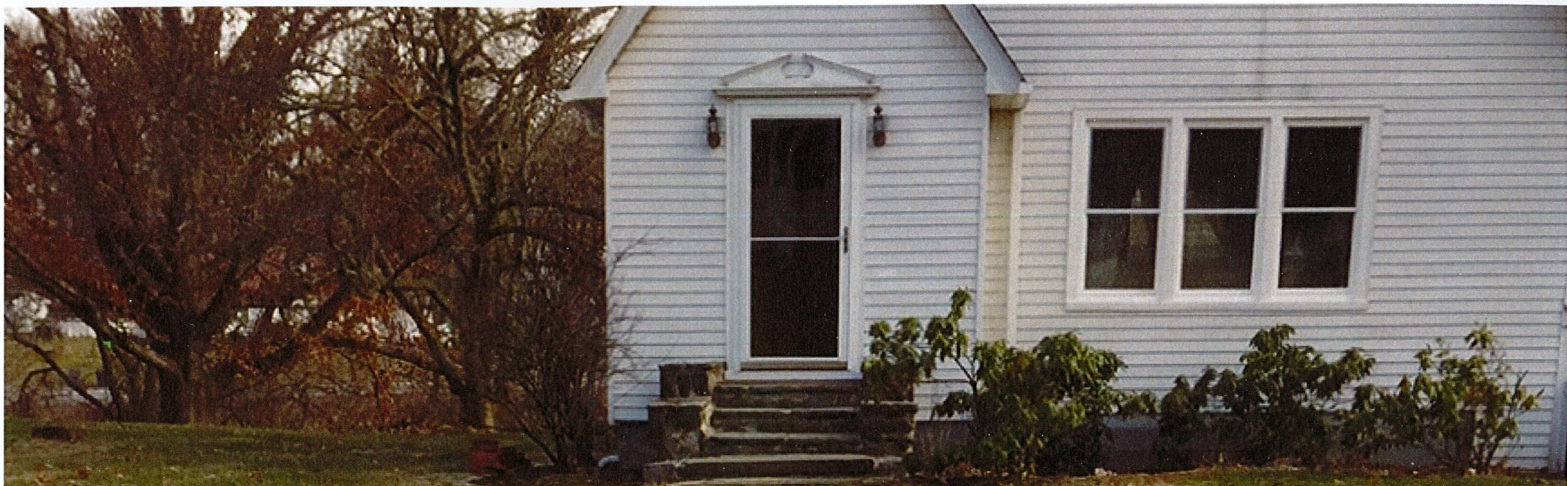
APPEAL FROM a zoning buffer pending an application for the first and second floors of a building located at 100 West Street, Newburgh, New York.
