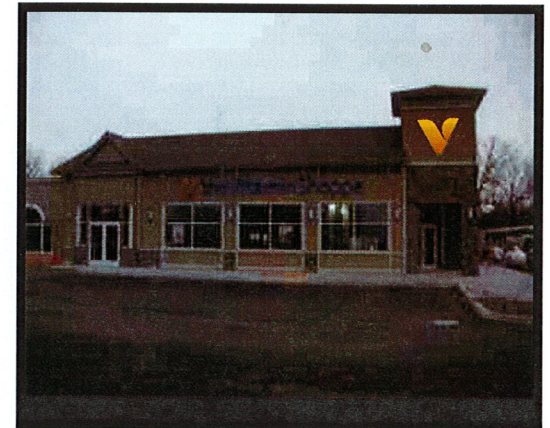


STORE ELEVATION (FRONT)

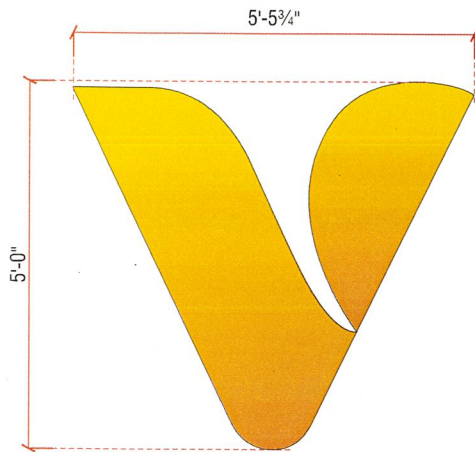

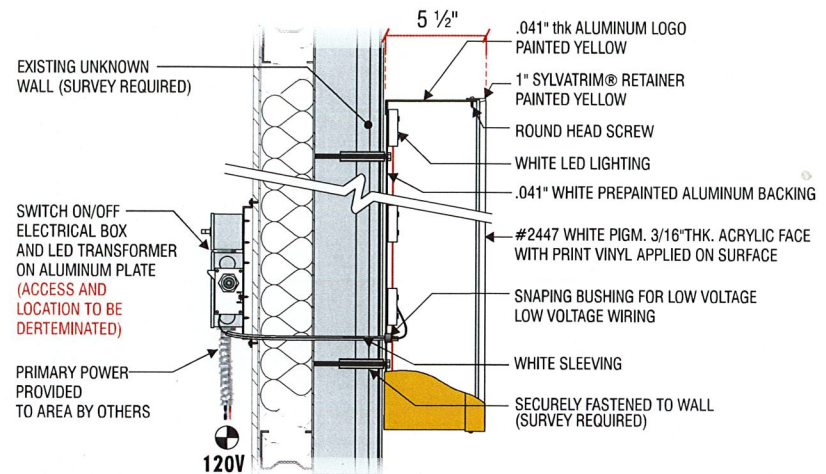
**A GRAPHIC ELEVATION**
