NOTICE OF PUBLIC HEARING
ON PROPOSED LOCAL LAW**

PLEASE TAKE NOTICE that there has been introduced before the Town Board of the Town of Newburgh in the County of Orange and State of New York on March 9, 2020, a Local Law designated as Introductory Local Law No. 2 of the Year 2020 and entitled "A Local Law Amending Chapter 185 Entitled 'Zoning' of the Code of the Town of Newburgh to Include the Uses of 'Nursery School for Pre-School Children' and 'Day Care Center' as a Permitted Principal Use Subject to Site Plan Review in the B Zoning District."

The purposes and effects of the Local Law are to permit nursery schools for pre-school children registered with the New York State Department of Education and Day Care Centers licensed by the New York State Office of Children and Family Services as principal uses in the Business (B) District subject to site plan review by the Planning Board. The Local Law will also allow accessory signs with the new uses in the B District and will add a supplemental regulation requiring that nursery schools for pre-school children and day care centers in the B zoning district have areas for the discharge and pick up of passengers from private vehicles on-site, outside of any highway or street right of way. The bulk requirements for nursery schools for pre-school children and day care centers in the B District will be as follows: lot area: 1 acre, lot width: 150 feet, lot depth: 150 feet, front yard: 50 feet, rear yard: 50 feet, 1 side yard: 40 feet, both side yards: 80 feet, lot building coverage : 20%, building height: 40 feet, lot surface coverage: 40%.

PLEASE TAKE FURTHER NOTICE that pursuant to Section Twenty of the Municipal Home Rule Law, a public hearing will be held on the aforesaid proposed Local Law before the Town Board of the Town of Newburgh at 7:00 o'clock p.m. on May 11, 2020 at which time all interested parties will be heard.

Due to public health and safety concerns related to COVID-19, the Town Board will NOT be conducting the public hearing in person. In accordance with the Governor's Executive Orders 202.1 and 202.15, the May 11, 2020 Town Board public hearings will be held via videoconference and a transcript will be posted on the Town's website at a later date. The public will have the opportunity to see and hear the public hearing live and provide comments either during the public hearing verbally or in writing by mail or email up to ten (10) days following the posting of the transcript on the Town's website.

INTRODUCTORY LOCAL LAW NO. 2 OF THE YEAR 2020
A LOCAL LAW AMENDING
CHAPTER 185 ENTITLED "ZONING"
OF THE CODE OF THE TOWN OF NEWBURGH TO
INCLUDE THE USES OF "NURSERY SCHOOL FOR PRE-SCHOOL CHILDREN"
AND "DAY CARE CENTER"
AS PERMITTED USES
SUBJECT TO SITE PLAN REVIEW
IN THE "B" ZONING DISTRICT

BE IT ENACTED by the Town Board of the Town of Newburgh as follows:

SECTION 1 – TITLE

This Local Law shall be referred to as "A Local Law amending Chapter 185 entitled 'Zoning' of the Code of the Town of Newburgh to include the uses of 'Nursery School for Pre-School Children' and 'Day Care Center' as permitted uses subject to site plan review in the 'B' Zoning District".

SECTION 2 – INTENT

The intent of this local law is to implement changes in the Town of Newburgh Zoning Code by amending the Use & Bulk Tables to add the uses of "Nursery School for Pre-School Children" and "Day Care Center" as permitted uses in the "B"- Business Zoning District and including appropriate bulk requirements for such use classification in the table for the "B" Zoning District.

SECTION 3 – AMENDMENT TO CHAPTER 185

A. Table of Use & Bulk Requirements, B District, Schedule 7, is hereby amended to add under column "D", "Uses Subject to Site Plan Review By The Planning Board", as a new item number "18", the uses of "Nursery School for pre-school children registered with NYS Dept of Education and day care center licensed by NYS OCFS, in accordance with §185-48.8"

B. Table of Use & Bulk Requirements, B District, Schedule 7, is hereby amended to add under column "B", "Permitted with" item "D18" in conjunction with items 6 "Signs in accordance with § 185-14 "b. Business" and "d. Identification" of Column A "Accessory Uses" as follows:

Table of Use & Bulk Requirements, B District, Schedule 7, is hereby amended to add under column "D", for the new items number "18", "Nursery school for pre-school children registered with NYS Dept of Education and day care center licensed by NYS OCFS, in accordance with §185-48.8", the following bulk requirements:

D. A new Section 185-48.8 is hereby added to Chapter 185 to read as follows:

“ §185.48.8 Day care centers and nursery schools for pre-school children.

Day Care Centers and Nursery Schools for pre-school children shall have areas for the discharge and pick up of passengers from private vehicles on-site, outside of any highway or street right of way.”

SECTION 4 – VALIDITY

If any clause, sentence, paragraph, word, section or part of this local law shall be adjudged by a court of competent jurisdiction to be unconstitutional, illegal or invalid, such judgment shall not affect, impair or invalidate the remainder thereof, but shall be confined in its operation to the clause, sentence, paragraph, word, section or part thereof directly involved in the controversy in which such judgment shall have been rendered.

SECTION 5 – EFFECTIVE DATE

This Local Law shall take effect immediately when it is filed in the Office of the New York State Secretary of State in accordance with Section 27 of the Municipal Home Rule Law.
