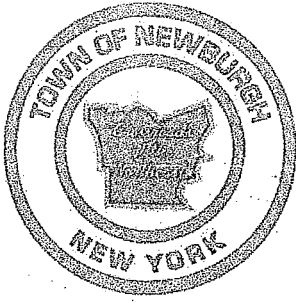

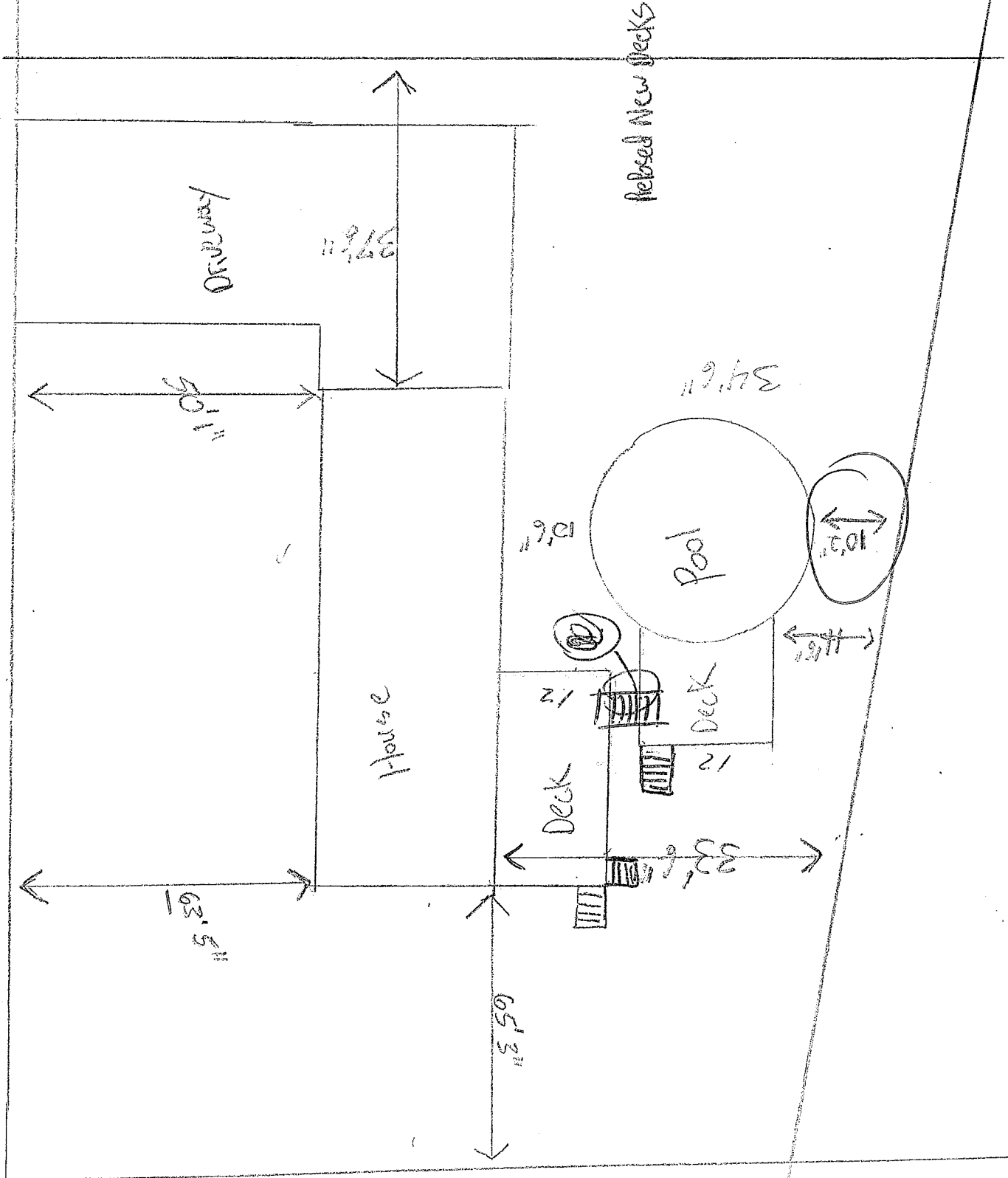

FIRST, that the Parties of the Second Part shall quietly enjoy the said premises;


SECOND, that the Party of the First Part will forever warrant the title to the said premises;

The word "party" shall be construed as if it read "parties" whenever the sense of this indenture so requires.


