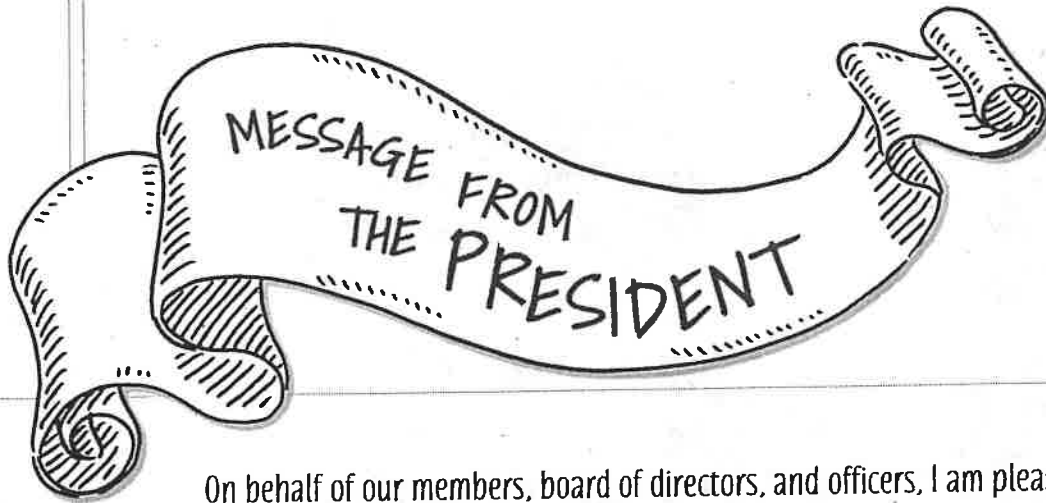

On behalf of our members, board of directors, and officers, I am pleased to present the New York Gaming Association (NYGA) 2018 Annual Report.

The state of our industry is strong and growing. In 2018, gross gaming revenues topped \$2 billion – a 3.3% increase despite some of the highest industry tax rates in the nation. And our special commitment to education has never been stronger. From the moment Video Lottery Terminals (VLTs) were first authorized by New York State in 2001, the performance of our industry has been inexorably tied to the funding of our schools. In 2018 alone, NYGA facilities generated more than \$900 million for New York schools, bringing our cumulative funding for education since 2004 to a prodigious \$9.2 billion.

New York's students, parents and teachers may be the principal beneficiaries of our members' success, but they are by no means the only winners. Local taxpayers, farmers, family-owned small businesses, construction workers and so many others benefit from the investments our members make in their host communities.

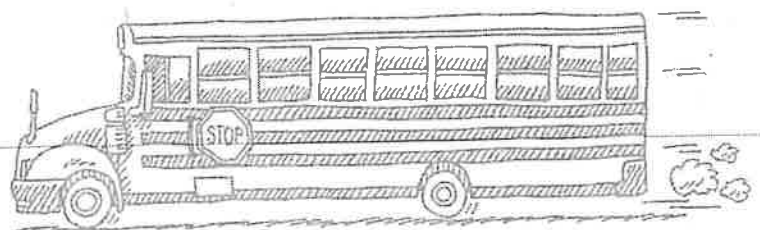

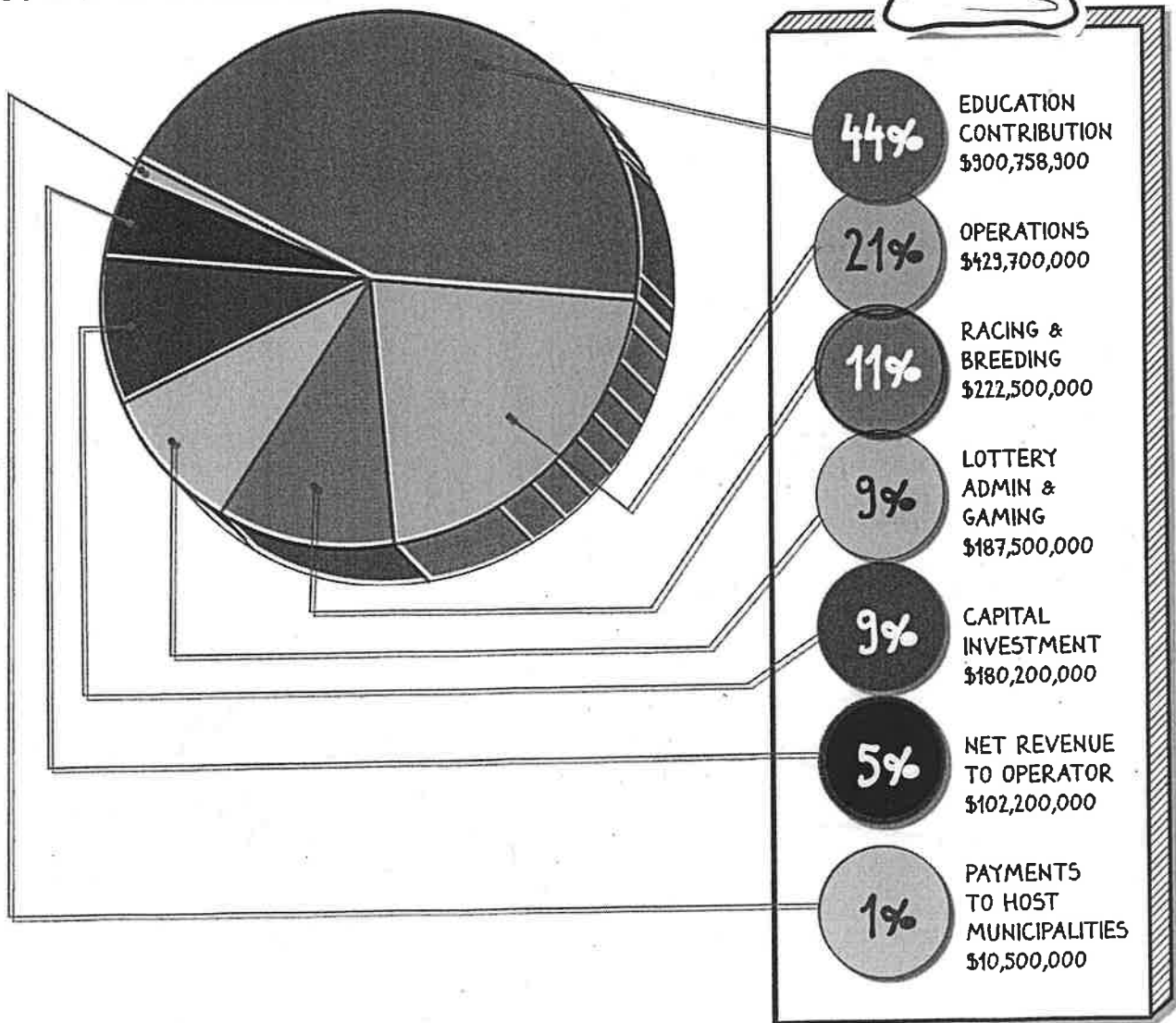

2018 Distribution of Gross Gaming Revenue

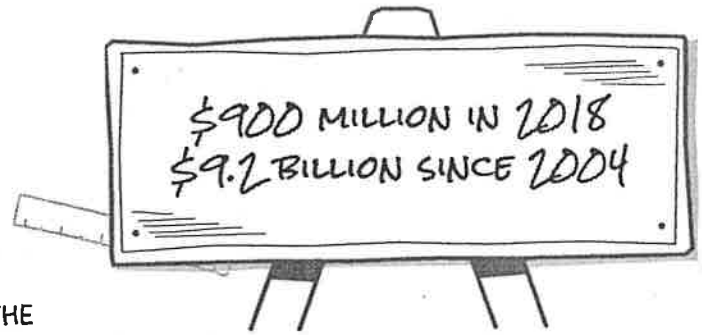
OFTEN REFERRED TO AS "NET WIN" OR THE "HOLD," GROSS GAMING REVENUE (GGR) IS THE TOTAL AMOUNT WAGERED AFTER WINNINGS WERE PAID OUT. GGR IS THE TRUEST MEASUREMENT OF THE ECONOMIC VALUE OF GAMING. NYGA MEMBERS' GGR TOPPED \$2.02 BILLION IN CY 2018, A 3.3% INCREASE OVER CY 2017.



DISTRIBUTION OF NYGA MEMBER GROSS GAMING REVENUE, CY 2018 (IN \$ MILLIONS)

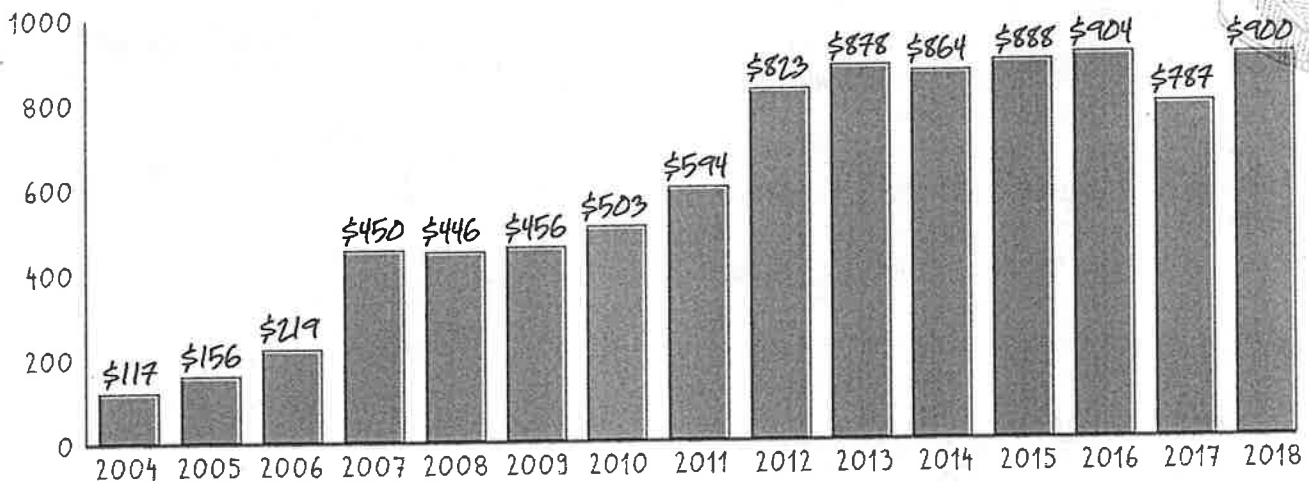


Education Funding



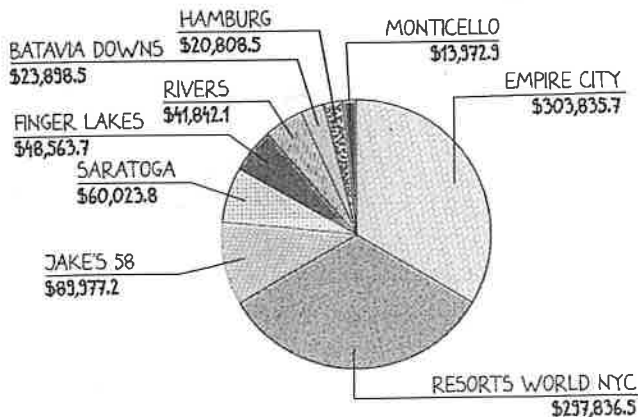
WHEN IT COMES TO EDUCATION FUNDING, NYGA IS AT THE HEAD OF THE CLASS. OUR MEMBERS HAVE DELIVERED MORE THAN \$9.2 BILLION FOR NEW YORK'S SCHOOLS SINCE VIDEO LOTTERY TERMINALS WERE FIRST AUTHORIZED BY THE STATE. IN 2018 ALONE, NYGA MEMBERS GENERATED A NEAR-RECORD \$900 MILLION FOR OUR STATE'S SCHOOLS, FULLY 44% OF GROSS GAMING REVENUES - MORE THAN ANY OTHER STATE. THIS SIGNIFICANT AND RELIABLE FUNDING HELPS ENSURE THAT TAXPAYERS HAVE RELIEF AND OUR EDUCATORS HAVE THE RESOURCES THEY NEED.

HISTORY OF NYGA MEMBER FUNDING FOR EDUCATION, CY 2004 - CY 2018 (IN \$ MILLIONS)



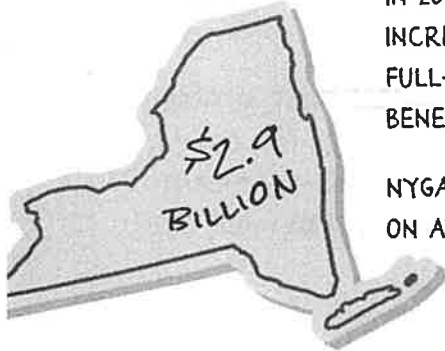

Statewide Economic Impact



IN 2018, NYGA MADE THE GRADE WITH MORE THAN \$2.9 BILLION IN ECONOMIC ACTIVITY, AN INCREASE OF 14% OVER 2017. THIS FIGURE INCLUDES THE SUM TOTAL OF THE WAGES OF ALL FULL-TIME-EQUIVALENT EMPLOYEES AND OTHER OUTPUTS FROM OUR MEMBERS INCLUDING BENEFITS AND THE PURCHASE OF GOODS AND SERVICES.

NYGA MEMBERS DIRECTLY EMPLOYED 5,271 EMPLOYEES IN 2018, AN INCREASE OF NEARLY 23%. ON AVERAGE, FULL-TIME NYGA MEMBER EMPLOYEES EARN ANNUAL WAGES THAT EXCEED NEW YORK STATE'S MEDIAN SALARY. WHEN INDIRECT EMPLOYMENT IS TAKEN INTO ACCOUNT, NYGA CAN CONFIDENTLY CLAIM THAT 26,865 INDIVIDUALS EARN THEIR LIVELIHOODS AS A RESULT OF ECONOMIC ACTIVITY GENERATED BY OUR MEMBERS.

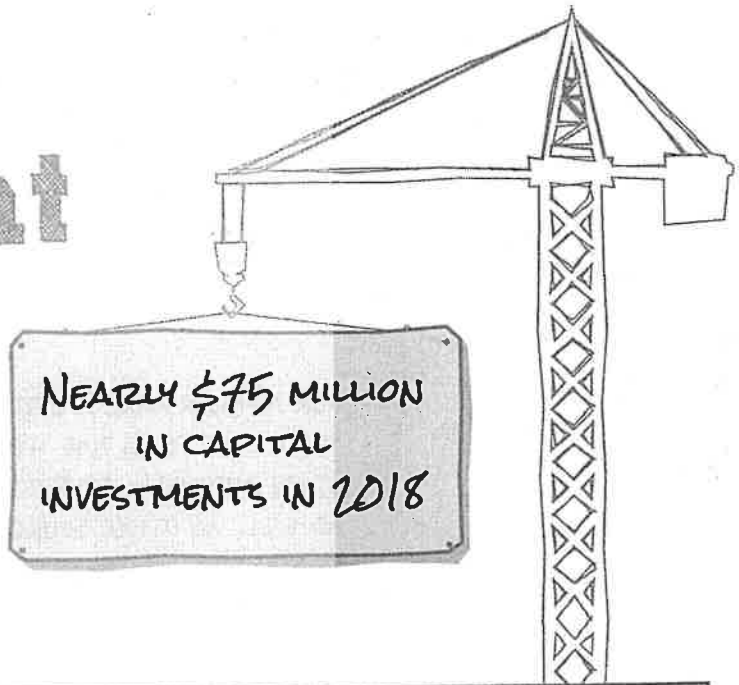

Capital Investment

NYGA MEMBERS SPENT \$74.8 MILLION ON NEW CONSTRUCTION AND EQUIPMENT IN 2018. OVER THE LIFETIME OF THEIR FACILITIES, NYGA MEMBERS HAVE MADE CAPITAL IMPROVEMENTS EXCEEDING \$2 BILLION. WHETHER EXPANDING OR UPGRADING EXISTING BUILDINGS OR IMPROVING RACING FACILITIES, THESE IMPORTANT INVESTMENTS SUPPORT CONSTRUCTION JOBS FOR HARDWORKING MEMBERS OF THE BUILDING TRADES.

IN CY 2018, NYGA MEMBER GROSS GAMING REVENUE TOTALED MORE THAN \$2 BILLION, OF WHICH NEARLY \$1.1 BILLION (54.1% OF TOTAL GGR) WAS DISTRIBUTED DIRECTLY TO NEW YORK STATE AND LOCAL GOVERNMENTS.

BETWEEN CY 2017 AND CY 2018, NYGA MEMBER GROSS GAMING REVENUE ROSE BY 3.3%.

OUR MEMBERS ARE A CRITICAL SOURCE OF INCOME FOR MANY NEW YORK MUNICIPALITIES. IN 2018, NYGA MEMBERS GENERATED MORE THAN \$105 MILLION FOR STATE AND LOCAL GOVERNMENTS THROUGH TAXES ON INCOME, SALES AND PROPERTY AS WELL AS OTHER SOURCES. SINCE 2007, THESE CONTRIBUTIONS TOTAL IN EXCESS OF \$582 MILLION. THESE FUNDS HELP STABILIZE AND REDUCE THE TAX BURDEN WHILE DEFRAYING COSTS ASSOCIATED WITH MEMBER FACILITIES. NYGA MEMBERS BENEFIT THEIR COMMUNITIES FINANCIALLY THROUGH DIRECT AID FROM THE STATE, TAXES PAID DIRECTLY TO LOCAL GOVERNMENTS, AND REVENUES GENERATED INDIRECTLY THROUGH SPENDING ON PAYROLL, PURCHASING AND CONSTRUCTION.

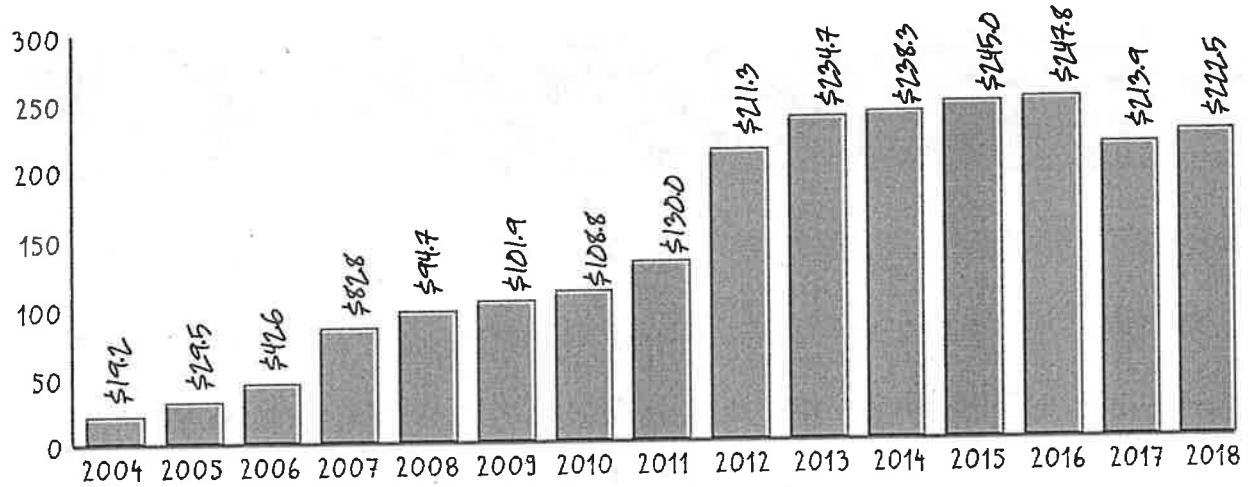

REVENUE FROM NYGA FACILITIES FUNDS STANDARDBRED AND THOROUGHBRED PURSES, BREEDING FUNDS, AND SUPPORT FOR A WIDE ARRAY OF AGRICULTURE-RELATED BUSINESSES INCLUDING TRAINERS, FAMILY FARMERS AND VETERINARIANS. IN 2018 ALONE, THIS SUPPORT EXCEEDED \$222 MILLION, HELPING PUSH THE TOTAL FROM 2004 THROUGH 2018 PAST THE \$2.1 BILLION MARK.
